### Para wise Statement of WP(C) No. 5727/2022.

An advertisement for filling up of a vacant sanctioned post of Asst. Professor in the subject Assamese (Group-B), Roster Point-12-UR, was published in two English Daily News Papers - The Assam Tribune and Assamese Daily Dainik Asom on 21-08-2019 (*Annexure-01*). And interview for the post was held on 02-06-2022 after observing all the formalities stated in the UGC Regulations 2009 and the Guidelines of the Govt. of Assam for Selection of the candidates for the post of Assistant Professor/Librarian against vacant sanctioned post(s) which was circulated by the Director of Higher Education Assam vide Memo. No. DHE/CE/Misc.49/2021/5-A, Dated Kahilipara the 9<sup>th</sup> February 2022.

Altogether we received 25 numbers of applications out of which 08 numbers of applicants appeared before the interview board on 02-06-2022 in which the petitioner Dipanjali Das Medhi was also present (*Annxure-02*).

All the candidates who were called for interview had the latest UGC qualifications and some of them had evidences of research and publication works which also carry points as specified by the UGC Regulations 2019.

- Para -06. Though it was stated in the said Advertisement that preference would be given to candidates belonging to BTC area subject to the fulfillment of all criteria, it was found that the **difference of Academic Scores and Average Scores** of the First Position Candidate in the general merit list Mrs. Parthana Burugohain, who secured an **Average Score of 64.33** and that of Dipanjali Das Medhi who belong to BTC area and secured an **Average Scored of 41.92**, is so vast that the Selection Committee or the Panel of Experts, approved by the Vice Chancellor of Bodoland University, with the objective of maintaining and imparting **Quality Education** to the students, as well as the college Governing Body were in no position to give preference to the candidate belonging to the BTC area (*Annexure -03*).
- <u>Para 07</u>. As a usual practice, the interviews for the post of Assistant Professors/Librarians are held in the respective college premises, and our college authority also organized the said interview in the college premises itself and the rest of the candidates, except the petitioner, had any complaint on it.
- <u>Para 08</u>. According to the baseless claim of the petitioner that she was the only local resident of BTAD area and is entitled to get preferential benefit. In fact, there were 4 (four) applicants for the said post from the BTAD Area out of which 3 (three), including the petitioner, turned up and face the interview (*Annexure-04*). As per the information from our reliable source, she collected this information from one of the members of the Panel of Experts, who breaching the professional ethics of an expert, passed the wrong information to the petitioner.

Para 09. The College Governing Body had a meeting on 18-07-2022 and discussed in detail regarding the selection of candidates and filling up of the vacant posts for which interviews were held for different posts of Assistant Professor, including that of Assamese (Group-B) of Unreserved (UR) category. There was a unanimous opinion among all the members that Tangla College, a premier institution of higher education in the backward area, has to impart quality education to the students, and hence, select the best candidates for appointment against the vacant posts of different subjects. So, the college Governing Body decided, vide Resolution No.05, (*Annexure-05*) to approve the selection list and recommendation of the Selection Committee/Panel of Experts and to forward the proposal to the Director of Education, BTC, Kokrajhar for final approval and appointment. The proposal for final approval and appointment was forwarded to the Director of Education, BTC, Kokrajhar on 10-08-2022 vide forwarding letter No. TC/Appointment/2022/2965, dated. 10-08-2022.

Hence, the College Governing Body has been taking its timely actions, and the question of delay in publishing the interview result does not arise.

And hence, the Interview Board of Expert and the college Governing Body represented by the President, Secretary/Principal have not done anything unfair, unjust and discriminatory.

Be it noted that, in pursuance to the proposal of the Tangla College Governing Body which was forwarded on 10-08-2022, the Director of Education, BTC, Kokrajhar has approved the proposal for appointment of Assistant Professor of Assamese (Group-B), category- Unreserved (UR) along with 7 (seven) others, and appointment orders have distributed to the respective candidates vide order No. **DE/BTC/Apptt./55/2017/651-A**, Dated 19-12-2022 (*Annexure-06*).

That, Mrs. Parthana Buragohain joined her duty as an Assistant Professor of Assamese on 20-12-2022. (*Annexure-07*)
