

Para wise Statement of WP(C) No. 6668/2019 submitted to Advocate, Gauhati High Court.

An advertisement for filling up of a vacant sanctioned post of Asst. Professor in the subject Banking/ Finance was published in the English Daily News Paper - The Assam Tribune, on 19-02-2016. And interview for the post was held on 12-01-2017 after observing all the formalities stated in the UGC Regulations 2009. Altogether we received 08 numbers of applications out of which 06 numbers of applicants appeared before the interview board on 12-01-2017 in which the petitioner Mr. Thubur Sun Swargowary.

Para -02. That the post of Asst. Professor in Banking/Finance was advertised for Unreserved Category, and hence question of considering candidate for being an ST(P), or for that matter, any other category, does not arise.

Para 03. All the candidates who were call for interview had the latest UGC qualifications and some of them had evidences of research and publication works which also carry points as specified by the UGC Regulations 2009.

Para 04. The result of the interview could not be made public immediately after the interview because Mr. Thubur Sun Swargowary, one of the candidates of the interview submitted a petition saying that he was the only candidate having **Major Course in Finance** at the degree level and he should be given preference in selection and then appointment for the post.

Therefore the College Governing Body felt necessary to seek clarification from the affiliating University i.e., Gauhati University regarding the subject taken by the candidates in their Undergraduate as well as in PG levels. As such, the Principal of the college communicated to the Academic Registrar, Gauhati University, seeking a clarification on this point (**Annexure-1**). And hence, the College Governing Body resolved to keep the proceedings of the whole process and result undeclared till the clarifications are received.

In response to our query, the Academic Registrar of GU replied that, "for eligible to be called for an interview and considered fit for selection for appointment against post which is named as Banking (Finance), specialisation in Accounting and Finance as per new PG syllabus and/or specialisation in Finance as per Old PG syllabus in the Master's Degree level is a requisite qualification" (**Annexure No. 02**).

Para 05. The Advertisement published on 19-02-2016 bearing Adv. No. CD/SV/P/4057/1, dtd. 19-02-2016 (**Annexure-03**) for the post of the Asst. Professor of Banking/ Finance is totally different from the 2 (two) posts of Asst. Professor in Commerce (Finance=1 and Accountancy=1) bearing Adv. No. CD/SV/P/SP002137/1, dtd. 21-08-2019 (**Annexure-04**). The Govt. sanction order No. for Advertisement of the earlier post was AHE.516/2014/4. Dtd. 11-08-2015 which was forwarded to the Principal of the college vide letter No. DE/BTC/Govt./Cir/10/2018/83, dtd. 26-09-2016 (**Annexure-05**), and that of the second advertisement bears Govt. sanction


No. AHE-760/2019/35, dtd. 06-07-2019 (**Annexure-06**). Moreover, the vacancy positions for different sanctioned permanent posts are to be shown clearly in the **Roster Registration** of the colleges which are approved by the Director of Education, BTC, Kokrajhar (for colleges within BTC) from which one can understand that, the posts advertised on 19-02-2016 is totally different from those of the advertisement published on 21-08-2019 (**Annexure-07: Roster Registration of Tangla College**). According to the college Roster Register, the post of Banking/Finance, advertised on 19-02-2016 falls under **Roster Point-1** (UR category and now **UR-PWD**), whereas, that of the second advertisement falls under **Roster Point-9** (UR category and now UR-EWS) and **Roster Point -11** (reserved for OBC/MOBC).

Para-06. The results of the petitioner are not as brilliant in comparison to those of other candidates who appeared in the interview. As per the guidelines of the Department of Education, Govt. of Assam there was no chance for the subject experts to award any point to the candidates for oral interview (**Annexure-08**). And hence, the score sheets of all the subject experts are filled up by looking at the Academic Record (Mark-sheets) of the respective candidates right from HSLC to PG levels and points secured from research, publications and teaching experiences in degree level educational institutions.

And hence, after receiving clarification from the Academic Registrar of GU, and a threadbare discussion in its meeting, the college Governing Body resolved to approve the selection and recommendation of the Interview Board of Experts and finalized the result of the interview, held on 12-01-2017, for the post of Asst. Professor in Banking/Finance and forwarded the proposal of appointment to the Director of Education, BTC, Kokrajhar for final approval and appointment.

The Director of Education, BTC approved the proposal of the Governing Body of Tangla College and appointed Mr. Shultan Samim Ahmed, who stood First Position in the Interview, as the Asst. Professor of Banking/Finance against the sanctioned permanent post vacancy vide order No. DE/BTC/Appt/55/Pt-I/2017/536-A dated Kokrajhar, the 12th December 2019 (**Annexure-9**). Mr. Sultan Shamim Ahmed joined his duty w.e.f. 17/12/2019 (**Annexure-10**) and now he has been performing his normal duty of teaching satisfactorily.
